### **Energy Footprint Tool for 2024**

Thank you for those of you who have completed the EFT over the last couple of months and so far, almost 40% of churches have entered their data. The EFT closes at the end of June but we would really appreciate an early response to this so that we can check the data well before the deadline. With this in mind I would be grateful if you could remind treasurers, as they finalise the end of year church accounts, to put the energy bills to one side to complete the EFT.

The aim of the <u>survey</u> is to help Historic England identify where gaps exist in the provision of training and guidance on emergency preparedness, response and recovery within our historic environment and the heritage sector.

### Appointing a new Quinquennial Inspector

A number of our longstanding Quinquennial Inspectors have decided to retire or reduce their workload and as a result a number of parishes will be needing to appoint a new inspector this year. I have been in touch with all of the parishes that I am aware of, but many have not yet requested DAC advice on their proposed appointment.

In the appointment of a person to carry out a quinquennial inspection, churches are encouraged to interview prospective inspectors. It has been brought to my attention of an issue elsewhere in the country when a PCC has asked questions that are not relevant to the appointment of an inspector. I would therefore like to remind PCCs that it is not appropriate to include interview questions around <u>protected characteristics</u> as this could leave the PCC open to challenge under the <u>Equality Act 2010</u>.

### **Disability Project**

All of the large grants allocated to our diocese have now been awarded, however applications for the small grants of up to £5,000 remain open. They are awarded on a first come first served basis, so if you have a project that might qualify, I would suggest that you get applications in as soon as possible. # **Online Faculty System Update**

The Online Faculty System is currently being redesigned and the new system will hopefully remove some of the issues that people have found with the current system. The faculty process itself will not change but how it appears on the online system will look different. The transfer to the new system looks likely to occur early in the Autumn but final details are still to confirmed. I will be doing some training over the summer and will confirm dates as soon as possible.

The current system for Durham Diocese currently has over 130 active faculties, however 80 of those have been issued and are waiting for parishes to confirm that the work has been completed. I would be grateful if you could check your parishes faculty records and update these as soon as possible. We also have a large number that were started some years ago but have not proceeded beyond the initial stage. I will remove those started before 2024 from the system unless parishes confirm that they are still planning to proceed with the work.

### **Heating**

If your church boiler is over 20 years old, now is the time to start considering options for the future. A boiler can fail at any point but if you have a boiler over 20 years old the chance is much greater and it is also more likely that parts may not be available for them. Since 2022, in line for the Church of England's Net Zero Carbon pledge, any new boilers have required a faculty application and as part of that application you have to be able to justify the replacement of a gas boiler rather than moving to a lower carbon heating solution.

If you have an oil boiler these cannot be replaced after 2025, so looking at alternatives now will save time when you need to find an alternative.

### **Net Zero Webinars**

If you are struggling to get your head around how your church can possibly get to Net Zero by 2030, you are not alone. We have no magic solution as every church building in the diocese is different and the usage of every building is different. #### 2. National Church Survey

The future of church buildings is the greatest heritage challenge facing the UK, but their contribution to society is often underappreciated, and the volunteers who support them are seldom heard. The National Churches Trust is conducting a major new survey to give a voice to those whose dedicated service cares for the country's 38,500 churches and presents an opportunity to celebrate the heritage and role of church buildings, bringing them to national attention. At a time when their future and funding is in jeopardy, this landmark study will reveal the current status of church buildings, how they are maintained, funded, and the support they provide for local communities. The survey will go live at the start of May 2025, and we encourage you to register in order that we can include your church in this study. The next round of the Living Alongside Bats in Churches grant is now open and will close at **9am on the 28 April**. These grants are especially intended to help churches who are facing another summer of lots of cleaning get the help they need. Grants can be awarded for:

- Pew covers
- New hoovers
- A telescopic brush
- Specialist cleaning
- Bat detectors for future events (in addition to cleaning equipment)

A requirement of the grant is that the church holds a positive community event inspired by nature. Examples of these include:

- Local schools having a bat day
- Several bat walks/evenings with local bat groups
- Bat inspired flower show
- Community event making pew covers
