Dear Churchwarden (and those who look after your Church Buildings),

Below is my monthly round up of information that might be of interest to you. Hopefully we have just about got our database updated with new churchwarden appointments but if you are no longer in post then please forward to your successor.

URGENT ACTION REQUIRED - Energy Footprint Tool for 2023 Energy Usage

The energy footprint tool (EFT) for you to enter your 2023 energy data closes at the end of July. The EFT is accessed via the parish returns website and guidance documents are available on the website.

The process has been simplified this year and basically all you need is the utility bills for each of your church buildings, however it would be really useful if you could enter the KWh data as well as the cost, as we have a wide range of energy tariffs depending on when you started your contract.

If you require any support in entering the data, please contact Bethan Still (Diocesan Environmental Officer) or myself. I appreciate that you may not be the person who has access to the energy bills, but I would be grateful if you could pass this on to your treasurer of PCC Secretary.

At present only 52% of parishes have entered their data. Completion of the EFT is a requirement of any Net Zero Funding and I would hate parishes to refused funding because this information was not provided.

General Election

I am aware that some churches may be using their premises as polling stations during the forthcoming General Election and this may increase the numbers of visitors coming into the building who are not so familiar with it. It may be useful for you to review their fire safety and health and safety arrangements and to check if any valuables need to be locked away. Diocesan Grants

Just a quick reminder that we have two diocesan grants currently available to support work on your church buildings. The **Minor Repairs and Improvement Grants** can be used for most repairs and improvements to a church building. The **Quick Wins Grants** can be used to support relatively small projects that will reduce the carbon output of you church building or church hall.

It is possible for churches to apply for both grants for eligible projects and therefore potentially receive up to 100% of the cost of the work.

The application forms are slightly different for both grants but should take no more than about 10 minutes to complete. The Church Building Panel considers applications on an on-going basis so a decision is usually made within a couple of weeks.

The Disability Project Parish Grants Scheme

From September 2024 parishes in the diocese will be able to apply for grants to support changes to their buildings that allow all people to access the buildings and engage in services and activities. Boilers and Heating Systems

Whilst it might seem strange to be talking about heating at a time of the year when we have probably just turned our heating systems off for the summer, but now is the time to think ahead. During the summer is the ideal time to get heating systems serviced and this should include the whole heating system every few years as well as the annual boiler servicing. Now is also a great time to start looking at alternative low carbon systems, so that you know what would be suitable for your building and a rough idea of the likely costs of such a system. That way if your heating does fail, you are in a position of being able to move ahead quickly with a replacement and maintain a warm building. If you would like me to visit your church to discuss which heating systems may be suitable, then please get in touch.

Treasure on church land

The Treasure (Designation) (Amendment) Order 2023 provides an exemption to the Treasure Act 1996 for objects subject to the faculty jurisdiction found on land which is itself subject to the faculty jurisdiction and held or controlled by an ecclesiastical corporation together with objects which are found in or under a cathedral church or within its precinct. We have now released guidance on how churches and cathedrals should treat these exempt objects should they be discovered. The guidance note includes an outline of what is defined as 'treasure' under the 1996 Act as amended in 2002 and 2023.
