

Dear Churchwarden (and those who look after your Church Buildings),

Since I have been in post, I have visited about two thirds of our churches. If I haven't yet visited your church I would love to come and see it and discuss any issues that you may have with the building, so do please get in touch.

Below is my monthly round up of information that might be of interest to you.

# Listed Places of Worship Grant Scheme (LPWGS)

The 30 October 2024 Budget contained no mention of the future of the Scheme. However, Chris Bryant MP, Minister for Creative Industries, Arts and Tourism, has confirmed that the future of the scheme beyond March 2025 will be a matter for the forthcoming Comprehensive Spending Review.

# Below is some guidance that I have received from the Historic Religious Buildings Alliance on how to send an email in support of the continuance of the Listed Places of Worship Grant Scheme beyond March 2025

1. In your subject line, put 'Attn: the Secretary of State (LPWGS)', or something similar. Make sure you say at the beginning why you are writing - to ask for the Listed Places of Worship Grant Scheme to be extended beyond March 2025.

2. If you have concrete experience of the Scheme, then in **just one or two paragraphs** explain what your project is/was for, and why the VAT refund is/was important. If the building is used for community activities, or is important to local people in other ways, say something about this. Do say if your work was funded by gifts and donations. Also mention if it involves action in response to climate change, or other environmental benefits. Also consider being explicit that you are grateful that government provides the Scheme!

# **Church Building Training 2025**

To help me plan the training programme for 2025, I would be grateful if you could complete this simple survey indicating the types of training that you think would be useful. <u>https://forms.gle/8NSdcXfkS68r631Y9</u> I try to host sessions around the diocese so if your church would like to host a session, then please let me know.

## <u>Heating</u>

As we head into the winter period, we have already had a number of heating failures across the diocese. Obviously a boiler can fail at any point but if you have a boiler over 20 years old the chance is much greater and it is also more likely that parts may not be available for them. Since 2022, in line for the Church of England's Net Zero Carbon pledge, any new boilers have required a faculty application and as part of that application you have to be able to justify the replacement of a gas boiler rather than moving to a lower carbon heating solution.

I would therefore encourage any churches with a boiler over 20 years old (or with known problems) to begin investigating the range of heating options that are available, so that you have a basic plan that can quickly be updated when the time comes. If you have an oil boiler these cannot be replaced after 2025, so looking at alternatives now will save time when you need to find an alternative.

#### **Contractor Database**

In December I will updating our database of contractors ready to send out a pdf version to you all in the new year. The information that I have is only as good as the information that I receive from parishes and I would be grateful if you could share details of any contractors that you have used and would be happy to recommend them. As a diocese we do not recommend any particular contractors but I am happy to pass on recommendations from other parishes.

#### **Grant Database**

We try to keep a simple grants database updated so that parishes know which grant providers to approach for particular projects that they are requiring funding for. As with the list of contractors, we only know if churches obtain grants from certain providers if you tell us.

If you have received any grants in the last few years, it would be really useful to know which grant providers you have used as they may be able to offer other churches a grant for their building projects. #### **Energy Footprint Tool for 2024**

The EFT for 2024 will open early in the new year and we would really appreciate an early response to this so that we have the data in the first part of the year. With this in mind I would be grateful if you could remind treasurers, as they start collating the end of year figures and documents for church accounts, to put the energy bills to one side to complete the EFT. I will confirm the date the EFT will open as soon as this is confirmed.

#### The Disability Project Parish Grants Scheme

Parishes in the diocese can now apply for grants to support changes to their buildings that allow all people to access the buildings and engage in services and activities. There will be some smaller grants of £5000 and larger grants of up to £50,000. Any completed applications should be sent to me. I will be meeting with the project lead monthly so you should expect an initial response within a month of application.
