Dear Churchwarden (and those who look after your Church Buildings),

Below is my monthly round up of information that might be of interest to you. Apologies to anyone who has had to wait longer than usual to get a response to an email or phone call, but September has been a very busy month.

Listed Places of Worship Grant Scheme (LPWGS)

The Scheme is currently set to run only until the end of March 2025 and as you will know from media reports, the government is looking very carefully at its patterns of expenditure in the run up to the late October budget. It would be sensible to confirm to the government how important and valued this grant scheme is, and ask them to continue it. If you, or anyone you know, has used the grant scheme, and thinks it worth retaining, you may want to send an email in its support? —

Below is some guidance that I have received from the Historic Religious Buildings Alliance on how to send an email in support of the continuance of the Listed Places of Worship Grant Scheme beyond March 2025

- 1. In your subject line, put 'Attn: the Secretary of State (LPWGS)', or something similar. Make sure you say at the beginning why you are writing to ask for the Listed Places of Worship Grant Scheme to be extended beyond March 2025.
- 2. If you have concrete experience of the Scheme, then in **just one or two paragraphs** explain what your project is/was for, and why the VAT refund is/was important. If the building is used for community activities, or is important to local people in other ways, say something about this. Do say if your work was funded by gifts and donations. Also mention if it involves action in response to climate change, or other environmental benefits. Also consider being explicit that you are grateful that government provides the Scheme!

Thank you for completing the Energy Footprint Tool for 2023

Thank you to everyone who has completed or encouraged others in your parish to the Energy Footprint Tool. We had over 94% of churches complete this tool for the last financial year and comparing it with the data from 2022 it shows a reduction in the amount of carbon that has been emitted by our churches. The EFT for 2024 will open early in the new year and we would really appreciate an early response to this so that we have the data in the first part of the year.

The Disability Project Parish Grants Scheme

Parishes in the diocese can now apply for grants to support changes to their buildings that allow all people to access the buildings and engage in services and activities. There will be some smaller grants of £5000 and larger grants of up to £50,000. Any completed applications should be sent to me. I will be meeting with the project lead monthly so you should expect an initial response within a month of application.

Movement for Good

You may be aware that Benefact Group (of which Ecclesiastical is part of) has an annual giving programme called 'Movement for Good'. For a charity to have a chance of receiving a donation through this scheme all that is needed is a

simple nomination through the Benefact Group website. More details on this can be found here; <u>Movement for Good-Nominate a charity for an award.</u>

The poster includes a handy QR code that goes straight to the nomination form and a church logo can also be added. There is also a short video people can watch which will walk them through the steps to generate a poster.

Hall survey
